## SUMMER of 2020— MEMORABLE OR FORGETTABLE?

### HIGHLIGHTS AND GSLRA ACTIVITIES

- Activities of the Board this summer were largely limited to telephone calls, distant dock visits and emails; however
- Membership recruiting continued—we engaged several new members but the total number of memberships collected was on the low side — typically we pick up 20-25 at our AGM which didn't happen yet; see Note by Dave Stephens, Membership Chair
- Water Testing—when the Muskoka Lakes Association (MLA) decided to cancel their program for small lake associations due to COVID, our resident tester offered to step up and do whatever he could to continue testing on some limited basis see Note on Water Testing by Joanne Smith
- Development—this area was quiet although the Town was still conducting site visits for permits etc. No news on this front is generally considered good news. We note that the Moody Bay property remains 'For Sale' as the owner has decided to sell the property outright rather than develop it as originally envisioned. We will continue to monitor this property as the Town approval becomes a perk when trying to sell in the future. Stay tuned
- Volunteerism—we have had 2 new cottage owners come forward to stand for election at our upcoming AGM. But there are several Executives who have

served for a long time — perhaps it is your time to consider joining the Board, for a two-year appointment. See Note regarding virtual Annual General Meeting (AGM) to be held <u>on Sunday, December 6,</u> 2020 at 2:00 pm.

- Water Safety and Courtesy to Neighbours Docks—every year I say the [new] boats get bigger while Gull and Silver Lakes get smaller. This summer was no different. And with new boats, typically comes new drivers and larger wakes. And COVID resulted in attracting many more visitorsboth daily and short term renters And the potential problem with that is a) lack of knowledge of the laws b) unfamiliarity with the lake geography c) unconscious lack of care for the safety of residents and d) lack of awareness of the damage inflicted on docks and tethered boats. - City Hall Issues—while the building was physically closed, the Town of Gravenhurst (TOG) was fully operational and I believe was successful at keeping the Lake Associations informed regarding issues of mutual interest such as garbage collection, Air B&B noise and crowding, Fire bans, Beach closures and business openings and closings [alerts].



## Water Testing Results for 2020/2019



The MLA (Muskoka Lakes Association) did not collect or analyze lake water quality in 2020, due to Covid-19 restrictions. However, our organization is very fortunate to have had the help of one of our members, Bruce Elliott, to continue the testing on Gull and Silver Lakes, along with helpers Anne Elliott and Greg Keast. Many thanks!! This included data collection of E. coli and Total Coliform numbers, as well as Secchi Disk, Temperature, and relative water level readings; the data collected also noted prior rainfall and any other pertinent factors, such as prevalence of Canada Geese. Phosphorus levels were not able to be tested due to the lab facility being closed down for the year. However, this value is monitored for long term trends, typically consistently increasing over 3-5 years before there is a major concern.

I have used Bruce's raw data to calculate the Means and Geometric Means in a manner similar to the MLA analysis, and recorded both 2020 and 2019 in the data table below:

- Larger E. coli numbers will result from large rainstorms (washing dog/bird feces into waterways)
- Aging sanitary sewer infrastructure can leak waste into storm sewers that run into lakes
- E. coli can survive and sometimes even reproduce outside of hosts, such as in stream sediments or in beach sand
- Higher temperatures = higher growth rates. Optimal =  $37^{\circ}$ C. Bacterial death =  $70^{\circ}$ C.

E. coli values at the Gull Lake Park dock are clearly much higher in 2020, although still below the MLA target critical value of 100 cfu/100ml. Note: The Simcoe Muskoka Dept of Health tests the actual beach area weekly, making beach advisories/closures as necessary. There can be a large difference in readings between the beach and our test site which is a few hundred metres away. Total coliforms are significantly higher in 2020. The clarity of Gull Lake improved slightly in 2020, while the clarity of Silver Lake decreased. Temperatures of both lakes increased.

## ADDITIONAL NOTES:

• The water level was about 3.5 inches lower in June 2020 than 2019, and about 4.5 inches higher in both July and August 2020.

• June: The flock of geese seemed to be spending most of its time at Gull Lake Park.

• June: Lake use by humans is less than other years. Could less water circulation due to less boat traffic be a main factor? Could a solution be to mount water agitators on the barge to get the water moving? Or is it because with fewer people around, the waterfowl have increased their presence in the park? ... continued on page 3

## WATER TESTING RESULTS FOR 2020 continued

• Through the warmer summer months, there was an increased use of the park and its facilities by visitors. (Some major concerns of poor behaviour have been discussed with the Town).

- I called the Simcoe Muskoka Department of Health on July 30th and spoke at length with one of the Health Inspectors re how and when sampling is done at Gull Lake Park. In short, they take 5 samples on one day each week. The Geometric Mean is important, as is each sample. If <u>any</u> sample is >400 cfu/100ml <u>or</u> if the Geometric Mean of the batch is >200 cfu/100ml, then an Advisory is posted. She also noted that she had inspected a nearby Splash Pad where there have been geese problems. This group is spraying with garlic, which is typically for mosquitoes but also deters geese. It must be repeated as it diminishes. She also noted that the geese have an annual molting period of about 6 weeks (late June to August) when they are flightless and typically spend more time in land areas where they can access water and food easily... like Gull Lake Park
- My husband and I spoke with the Muskoka Goose Control in mid-August. They (Kim French and her husband) patrol with a dog and remove goose feces from several parks and one golf course. Gull Lake Park was their "hot spot" this year, being the only location where the geese numbers are "out of control". Her count (mine too) was 32 + 1 lonely male. There was a high reproductive rate this year, therefore even more geese can be expected here next year. The team collected ≥150 lbs daily, much higher than 2019. Nests are not in the park vicinity, so they cannot control that part. She also noted that she has had success with using a kayak to send geese away on other sites and has asked for the use of a kayak at the Lifeguard Station to do so....She also suggested more calls being made to the Town re By-Laws andComplaints. Gull Lake Park is under the jurisdiction of the Town, not our GSLRA. However, the issues/concerns occurring there have an effect on the health and safety of Gull Lake and the enjoyment of residents of both Gull Lake and Silver Lake.....

## Respectful boating guidelines from Safe Quiet Lakes

- 1. I will never operate my boat beyond the level of my skills.
- I will be aware of and obey all laws and regulations governing operation of my boat.
- I will operate my boat with caution and courtesy to others at all times.
- I will minimize my wake impact on shorelines, docks, structures and people.
- I will always steer well clear of other boats, swimmers and wildlife.
- 6. I will set a speed and heading that is safe and comfortable for my passengers and others on the water.
- I will provide safety instructions and offer appropriate life jackets or PFDs to everyone who travels in my boat.
- I will carry all equipment necessary to operate my boat safely and within the law.
- I will not consume drugs and alcohol in my boat or allow my boat to be operated by anyone who is impaired.
- **10.** I understand that boating is a shared experience and I will not create excessive noise or operate my boat in a manner that disrupts the peaceful enjoyment of the lake by others.
